This needs to be done as an emergency since they need the ordinance back right away. We asked them to bid the alley approaches, so once they bid the project we will get those numbers. The property where Downeys house was, they will not be rebuilding there. They will first offer the property to the Grimms and then to the Village if they don't want it. Administrator stated thinking down the road 5 to 10 years this site would be a great area for a municipal building. He asked Council to think about it for a future plan.
